- 4) Enclose self-addressed stamped envelope for jury notification (CD's will NOT be returned).

**REQUIREMENTS**

The exhibition will include work in ANY MEDIA, completed since January 2010.

**Work may not exceed 15" in any Direction(if 2D, including frame).** Work exhibited in prior MAG Small Work exhibitions will NOT be eligible. Entries will be juried from digital images on CD.

**CD Requirements:**

Jpeg images on a CD, with a resolution of 72dpi, a maximum of 600 pixels in the longest dimension, and a file size of 1MB or less. JPEG file name should be as follows:

**LastName\_FirstInitial\_Title\_Medium\_1.jpg** (or 2,3,etc). Please be sure file name and number of image on CD matches file name and number on entry form. Please write your name, address, and phone number on the CD. Use one CD for all entries.

**ENTRY FEE**

Minimum entry fee is \$35 for up to 3 entries. Additional entries are \$10 each, up to a maximum of 5 entries. Copy attached entry form as necessary. Form may also be downloaded from MAG website. Enclose a self-addressed stamped envelope for jury notification. **CDs will not be returned.**

Please do NOT send resumes, bios photographs, etc. with entries.

Entry material for accepted work will be held for the duration of the exhibition for publicity purposes.

Make check or money order (NO CASH) payable to Mamaroneck Artists Guild.

**Entry fees are non-refundable.**

**LIABILITY & INSURANCE**

Every care will be taken to provide for the safety of all artwork.

MAG, its officers and agents will not be responsible for any loss or damage.

**MAG does not insure entries and exhibits.** Works will be handled and exhibited at artist's own risk.

**ACCEPTED WORK**

All 2D work must be suitably framed and wired for hanging ( no sawtooth hangers). Accepted work which significantly differs from CD may be excluded. No substitutions for accepted work will be permitted. Submitted work MUST be available for entire exhibition.

**RECEIVING & REMOVAL OF WORK**

Shipped work must arrive at Mamaroneck Artists Guild between Tuesday May 1 & Friday May 4. All shipped work MUST include PREPAID RETURN SHIPPING LABEL and appropriate packaging for return of artwork.

Receiving of hand delivered work is on Monday May 7 from 12-7p.m.

All work must be removed by JUNE 12, 2012. If work is not removed by June 12, 2012, there will be a \$35 administrative fee and storage charge of \$5 per day. After 30 days, the art, including all rights, title and interest of the artist in and to the work, will become the property of MAG.

**SALES**

**ALL WORK MUST BE FOR SALE.**

Every effort will be made to sell artwork.

A commission of 40% will be charged on all sales. **PRICE MAY NOT BE CHANGED FROM PRICE LISTED ON ENTRY FORM.**
